(1) Logo

The color graphic on your label can be your logo, another graphic of your choice or simply your company name. Submit it by [email](#) in an .eps file, a .tif file or a .jpg file. It should be in RBG color scale (red, blue, green), with 300 DPI (dots per inch). Dimensions should be minimum 500 X 500 pixels and maximum 900 X 900 pixels. We do not provide creative/design services; however, we will change the file type or resize your graphic into the proper format for a \$25.00 formatting charge. You will receive a sample proof of your label after we receive all of your information.

(2) Declaration of Responsibility

Please indicate how you would like your declaration of responsibility to read. There is a maximum of 36 characters for the company name and 36 characters for the city, state and zip code. Please remember that spaces and punctuation count as characters. *Please type or write the company name, city, state and zip code exactly as it will appear on the label.* (Example: Midwest Groundcovers, MIDWEST GROUNDCOVERS, MIDWEST Groundcovers, St. Charles, ST. Charles, ST. CHARLES, IL, Il. Illinois, ILLINOIS)

There is a one-time custom program set-up charge of \$75 per company. We will invoice you upon receipt of this document.

Custom labels cost \$0.15 each. Label costs are valid from Dec. 1 of the current year to Dec. 1 of the following year. One custom label will be affixed to each container unless you or an agent of your company request otherwise. Label costs are not subject to EVD or pick-up discounts and will appear on the order and invoice. If the labels have been printed and you cancel your order, you will be charged for the labels.
